Department of Political Science and International Relations

The Department of Political Science and International Relations will accept its first students in the fall semester of the 2025-2026 academic year as one of the programmes currently offered in the Faculty of Economics and Business Administration at International University of Alasia (IUA).

The Department is recognized by the **Higher Education Planning**, **Evaluation**, **Accreditation**, and **Coordination Council** (YÖDAK) of Northern Cyprus.

The Department offers formal education in English. An academic year includes two semesters, Fall and Spring, each lasting at least 14 weeks. The academic calendar to be used in conjunction with the program is determined every year by the University Senate's decision.

The Department of Political Science and International Relations offers a curriculum that includes both required and elective courses covering government policy, policy processes, political theory, legal studies, and international relations. The program has a strong research focus, designed to prepare students for graduate study across a range of disciplines, as well as for entry-level careers in various fields. This comprehensive program introduces students to the broader framework of political science and is ideal for those interested in politics, foreign relations, international law, immigration, environmental issues, or pursuing a solid academic foundation in public opinion research and political campaigns.

Courses in the department are largely theoretical. However, in some courses, assignments, presentations, and debates may be among the evaluation criteria. Some semesters have prerequisite courses that require registration or passing one or more courses taken in previous semesters. In the current credit system, for each course, the evaluation criteria for the semester (midterm exams, homework, presentation, course participation, final exam, make-up exam, re-sit exam) and their weights are determined and acknowledged by the lecturers.

Some classes may be reoffered in the so-called "Summer School". The purpose of the Summer School is to offer classes for students who have taken and failed, or who are having to retake some courses, to raise their CGPA. Summer School has a compressed 7-week duration, where the weekly class hours have been doubled.

The university awards a 4-year **Bachelor of Arts (BA)** degree in **Political Science and International Relations** upon completion of the programme's curriculum, which corresponds to 122 credits (240 ECTS). The diplomas explicitly state the length of the education (4 years) and the degree awarded.

Mission

The mission of the Political Science and International Relations Department is to provide quality education that helps build in undergraduates the characteristics of high intellect, academic integrity, enlightened citizenship, solidarity, and responsible leadership in the public and private sectors. The department is also committed to serving the community by enhancing awareness about local and global politics, democratic government, law, human rights, international law, peace, and other basic areas of politics and international relations; and by connecting it to the rest of the world through educational networks of cooperation and original research.

Vision

Our vision is to cultivate our students—who come from a wide range of countries—into the next generation of leaders, politicians, managers, and scholars with a deep understanding of political dynamics, ethical leadership principles, and the ability to navigate complex socio-political environments. We aim to empower our graduates to become catalysts for positive change, promote inclusive governance, uphold democratic values, and advance social justice and human rights.

Aim of the Programme

The aim of the Programme is to provide advanced knowledge in the field of Political Science, and in the sub-field of International Relations. The main aim is achieved through the following objectives:

- -examination and explanation of the different perspectives, theoretical and methodological approaches of both Political Science and International Relations
- -examination and explanation of the main domestic and international politics problems, and the ways of resolving or managing their implications
- -examination and explanation of the policy formulation processes and implementation tools in local, regional and international levels
- -examination and explanation of diachronic and contemporary questions of political theory
- examination and explanation of one international and/or political theoretical issue through the completion of a dissertation.

POL211	TURKISH FOREIGN POLICY	2+0	3	4	This course introduces students to conceptual and theoretical explanations of the changes in Turkish Foreign Policy after the Cold War and also provides information about the dynamics and motivations behind changes in Turkish Foreign Policy.
POL213	MIDDLE EAST POLITICS	2+0	3	4	The Middle East in world affairs, international relations, and domestic policies of contemporary states in the Middle East: policies and strategy of major powers; supranational movements, regional political and security organizations. The area comprises Turkey, Iran, Afghanistan, Israel, and the Arab countries.
POL212	LAW AND INSTITUTIONS OF THE EU	2+0	3	4	The course is an introduction to European Union Law. The course considers a legal and political system that has become the most formidable system of transnational government in modern times. It is also a system that has become, in recent years, a source of continual political conflict: both over the content of its measures and the presence of its involvement in many spheres of activity. Discussions on the democratic nature of the EU, the relationship between the welfare state and EU law, and its very existence, for example, will be covered in this course.
POL214	POLITICS IN THE BALKANS	2+0	3	4	The topics covered in the course are: History of the Balkans. the territorial settlement of 1919-1923. revisionism in the Balkans. Characteristics of the regimes during the period between the two World Wars. The establishment of communist regimes in the 1940s and their subsequent collapse in the 1989-1990 period. International and domestic problems faced by the

					Balkan states during the transitional period are examined. with
					emphasis on current 'hot' issues in the Balkans.
POL311	THEORIES OF DEMOCRACY	2+0	3	4	This course explores the concept and theories of democracy, with a focus on the "People"—who constitute the people, how popular will is embodied, and how it may be expressed. The course explores debates about different models of democracy and examines how alternatives to democracy, such as dictatorship, autocracy, and tyranny, have been conceptualized. Also studies democracy and its "others" with a constellation of concepts including power, equality, participation, accountability, resistance, legitimacy, and the rule of law.
POL313	FOREIGN POLICY ANALYSIS	2+0	3	4	This course covers the literature, research topics, and current issues in the area of foreign policy analysis. The course is organized in a basic "levels of analysis" framework that roughly corresponds to the historical development of the study of foreign policy analysis. Particular attention will be paid to current decision-making approaches to foreign policy. The emphasis in the course is on theories of foreign policy, although students will also be exposed to the process of the foreign policies of various countries.
POL315	FEMINIST POLITICAL THEORIES	2+0	3	4	This course covers some of the central debates in contemporary feminist political theory, with a particular emphasis on the legacy and usefulness of liberalism. Among the problems raised are conceptions of the individual and individual autonomy; the relative invisibility of gender issues in mainstream literature on justice and equality; the tendency to conceive of equality in sex-blind terms; and the tendency to presume a universally applicable set of norms.
POL317	INTERNATIONA L SECURITY	2+0	3	4	This course provides a comprehensive overview of key concepts, theories, and practices in international security within the context of international relations. The students will explore the fundamental principles of international security, including the role of international organizations, such as the UN, OSCE, and NATO. The course will cover topics such as arms control, conflict prevention, mediation, and peacebuilding, offering insights into the complex dynamics of global security.
POL312	NGO's and CIVIL SOCIETY	2+0	3	4	In this course, the students will cover theoretical and practical insights concerning the role of civil society and NGOs and will learn about different types of organizations (and their strategies, activities, and approaches. The students will also explore the interfaces of these organizations and institutions with culture, gender, human rights, indigenous rights, and dominant ideologies. Finally, the students will explore the links between civil society, NGOs, and other development actors.
POL314	ASIA-PACIFIC IN WORLD POLITICS	2+0	3	4	Comparative analysis of political change and rapid economic development in East and Southeast Asia, with particular focus on Japan, China, and the East Asian NICs.
POL316	TERRORISM IN INTERNATIONA L POLITICS	2+0	3	4	This course explores the influence of political violence broadly defined within contemporary international relations. The course traces the rise of existential threats to the state from non-state actors, it considers the spectrum of state and transnational initiatives and responses to ameliorate those threats, and reflects on how prevailing global political conflicts are refracted through the prism(s) of counter-terrorism.

POL413	SOCIAL POLICY	2+0	3	6	The course explores how welfare issues are constructed and debated in contemporary society. It revolves around three main themes: social needs, social problems and social rights, and how different debates about welfare have been influenced by these themes. It focuses on the implications of social change for debates about welfare, considering some of the major contemporary issues in social policy. This half course is complementary to Politics of the Welfare State.
LAW41 1	SETTLEMENT OF INTERNATIONA L DISPUTES and THE ICJ	2+0	3	6	The objective of this course is to provide students with an in-depth knowledge of the different mechanisms available in international law for the settlement of disputes, of the scope of jurisdiction of international courts and tribunals, and of the procedural rules applicable to cases brought before them
POL417	US POST-COLD WAR FOREIGN POLICY	2+0	3	6	This course examines the sources of American foreign policy. It reviews how Realism and Liberalism's approaches to international relations explain U.S. foreign policy. It also uses these approaches to examine pivotal events, actors, and developments in U.S. foreign policy since World War II, and address current issues in U.S. foreign policy.
LAW41 2	INTERNATIONA L MARITIME LAW	2+0	3	6	The purpose of this course is to provide students with the core principles of the public maritime law and the law of the sea. Students will be familiarised with the relevant international organisations that regulate public maritime affairs. They will provide an analysis of the maritime zones, the nationality of ships, as well as the rules and regulations on maritime safety, maritime safety and marine pollution.
POL412	RUSSIAN POST-COLD WAR FOREIGN POLICY	2+0	3	6	The course is aimed at understanding sources of continuity and discontinuity in contemporary Russian Foreign Policy, after the end of the Cold War and dissolution of the USSR. Specificity and general patterns of the subject are studied with specific theoretical instruments and a necessary empirical background. The course focuses on theoretical instruments of the Russian Foreign Policy analyses, factors of internal and external nature that shape Russian Foreign policy, its evolution since the early 1990s, as well as Russian Foreign Policy towards the major centres of power, key regions and international organizations.
LAW41 4	INTERNATIONA L CRIMINAL LAW	2+0	3	6	This course introduces students to international criminal law, broadly defined to include substantive and procedural rules applicable to core international crimes (e.g., war crimes, genocide, crimes against humanity) and transnational crime (e.g., piracy, migrant smuggling). Using case studies, students analyse the field's historical origins, evolution, and present-day implementation. Among others, post-WWII tribunals, the international tribunals of Yugoslavia and Rwanda, hybrid tribunals, and the International Criminal Court are studied.
POL415	INTERNATIONA L CONFLICT AND CONFLICT RESOLUTION	2+0	3	6	This course examines the application of conflict resolution theories to interstate crises and civil wars by international organizations like the UN and NATO, states, and ad hoc coalitions of states and non-government entities. The focus will be on the post-Cold War conflicts.
